5) ORDER APPROVING OR DISAPPROVING TO PAY CLAIMS, SALARIES AND WAGES AGAINST COUNTY FUNDS

Commissioner Leach made the motion to approve to pay claims, salaries and wages of \$124,626.32 Commissioner Day seconded the motion. All approved.

6) ORDER APPROVING OR DISAPPROVING TO PAY CLAIMS, SALARIES AND WAGES AGAINST PRECINCT FUNDS

Commissioner Koonsman made the motion to approve to pay claims, salaries and wages against precinct funds. Commissioner Schmidt seconded the motion. All approved.

After additional discussion Commissioner Day amended his motion to advertise for a design to build and ask for proposals for a 1600 square foot floor plan with a 10 foot awning, proposal to include everything including site preparation. Commissioner Koonsman seconded the motion. Commissioner Schmidt, Commissioner Koonsman and Commissioner Day voting for, Commissioner Leach voting against.

21) DISCUSSION AND ACTION ON BURN BAN

Commissioner Schmidt made the motion to lift the burn ban. Seconded by Commissioner Leach. All approved.

Judge Ratliff announced that he has been in contact with TAC and put it on list serve about volunteers for the county. He is still checking into it. He also announced that a nationwide company is looking at a potential place for a wind farm.
