# FIRST AMENDMENT TO THE APPLICATION FOR PROBATE OF WILL AND ISSUANCE OF LETTERS TESTAMENTARY

To the Honorable Judge of the Court:

Gregory F. Sharp, *Applicant*, furnishes this First Amendment to the Application for Probate of Will and Issuance of Letters Testamentary to correct the Will beneficiaries per Texas Estates Code 255.153, and furnishes the following information to the Court for the probate of the written Will of Dolores Ann Sharp, *Decedent*, and for issuance of *Letters Testamentary*:

- Applicant is an individual interested in this estate, domiciled in and residing at 1223 Engle Ave., Dallas, Dallas County, Texas 75224. The last three digits of Applicant's Social Security and Texas driver's license numbers are 630 and 167, respectively.
- Decedent died on November 28, 2023, at Medical City Fort Worth, in Fort Worth, Tarrant County, Texas 76104, at the age of 94 years. The last three digits of Decedent's Social Security and identification card numbers are 362 and 395, respectively.
