# APPLICATION FOR INDEPENDENT ADMINISTRATION AND LETTERS OF INDEPENDENT ADMINISTRATION PURSUANT TO SECTION 401.003 OF THE TEXAS ESTATES CODE

### TO THE HONORABLE JUDGE OF SAID COURT:

Krystal Lynn West Roberts ("Applicant"), furnishes the following information to the Court in support of this Application for Independent Administration of the Estate of Joe Edward West ("Decedent"), and for issuance of Letters of Independent Administration pursuant to Section 401.003 of the Texas Estates Code:

- 1. Applicant Krystal Lynn West Roberts is an individual interested in this Estate, being domiciled in and residing at 4620 CR 2720, Caddo Mills, Texas 75135. Krystal Lynn West Roberts is the daughter of Decedent. The last three digits of the social security number of Krystal Lynn West Roberts are 793. The last three digits of the driver's license number of Krystal Lynn West Roberts are 920.
- 2. Decedent died intestate on March 1, 2024, at Meridian, Bosque County, Texas, at the age of 82 years. Decedent's domicile at the time of his death

was 10201 HWY 8, Meridian, Bosque County, Texas 76665. The last three digits of the social security number of Decedent are 844. The last three digits of the driver's license of Decedent are 429.

- 3. This Court has jurisdiction and venue is proper because Decedent was domiciled in Texas and had a fixed place of residence in this County on the date of his death.

- 6. A necessity exists for the administration of the Estate, in that there is real estate in decedent's name that needs clearing and there are debts owed by the Estate.
- 7. The listing of heirs includes any living child of the decedent.

inventory, appraisement, and list of claims of such estate; and that all other Orders be entered as the Court may deem proper.
