APPLICATION TO DETERMINE HEIRSHIP, FOR LETTERS OF INDEPENDENT ADMINISTRATION, AND FOR APPOINTMENT OF ATTORNEY AD LITEM

TO THE HONORABLE JUDGE OF SAID COURT:

NOW COMES SIARA LEWIS ("Applicant") and makes this Application for Determination of Heirship, for Letters of Independent Administration, and for Appointment of Attorney Ad Litem ("Application"). In Support of this Application, Applicant furnishes the following information to the Court pursuant to Texas Estate Code § 301.051-52 and would show the following:

Application for Letters of Independent Administration

- William Lewis ("Decedent") died on August 22, 2024 in Iredell, Bosque County, Texas, at the age of 41 years. The last three digits of the Decedent's driver's license number are 458, and the last three digits of the Decedent's social security number were 765.
- 2. Applicant, Siara Lewis is the Decedent's living spouse. Applicant is domiciled at 431 County Road 2594, Iredell, Texas 76649. The last three digits of Applicant's driver's license number are 420, and the last three digits of her social security number are 487.
- 3. To the best of Applicant's knowledge and belief, Decedent died intestate.
- 4. This Court has jurisdiction and venue is proper in Bosque County because Decedent was domiciled and had a fixed place of residence in this County prior to the date of his death.

- At the time of his death, Decedent owned business and residential properties, personal bank accounts, investment accounts, and assorted personal effects of a probable value in excess of \$100,000.00.
- 6. 
