“CONSIDER AND TAKE APPROPRIATE ACTION ON A RESOLUTION AND ORDER AUTHORIZING THE COUNTY TO ENTER INTO A TAX ABATEMENT AGREEMENT PURSUANT TO THE COUNTY’S GUIDELINES AND CRITERIA UNDER THE PROPERTY REDEVELOPMENT AND TAX ABATEMENT ACT, CHAPTER 312 OF THE TEXAS TAX CODE AS REQUESTED BY CYRUSONE LP FOR APPROXIMATELY \$400,000,000 IN IMPROVEMENTS RELATED TO A FACILITY DESIGNED FOR LEASE TO DATA CENTER TENANTS. THE PROPERTY SUBJECT TO THE ABATEMENT AGREEMENT COMPRISES APPROXIMATELY 270 ACRES AND IS LOCATED IN EASTERN BOSQUE COUNTY, APPROXIMATELY 1 MILE SOUTH OF LAKE WHITNEY, ¾ MILE WEST OF THE BRAZOS RIVER, ALONG COUNTY ROAD 3610A.
