

Applicant: ANDREW GUTTERSEN

Decedent: MICHAEL WILLIAM GUTTERSEN

Applicant, ANDREW GUTTERSEN, resides at 8356 Stay Sail Drive, Windsor, Colorado 80528, and may be served by and through his Resident Agent, Keith Morris, at 1212 W. El Paso Street, Fort Worth, Tarrant County, Texas 76102. Applicant claims to be the owner of all or part of Decedent's estate. The last three digits of Applicant's Social Security number are 251. The last three digits of Applicant's Colorado driver's license are 771.

Applicant has standing to file this application as he is the son of the Decedent and an heir of this Estate, and to commence a proceeding to determine whether there is a need for administration of Decedent's estate, and shows the Court as follows:

1. Facts and Place of Death

MICHAEL WILLIAM GUTTERSEN ("Decedent"), died on November 29, 2024, in Scottsdale, Arizona at the age of 63 years old having been born on February 17, 1961.

2. Domicile of Decedent on Date of Death

Decedent, who died intestate, was domiciled at 560 County Road 2357, Meridan, Bosque County, Texas 76665

3. Decedent's Identifying Information

The last three digits of Decedent's Social Security number are 201. The last three digits of the Decedent's Texas driver's license are 797.

4. Jurisdiction and Venue

This Court has jurisdiction over this matter and venue is proper because Decedent resided in this county and had a domicile or fixed place of residence in Texas.

5. Time Between Date of Death and Application

Four years have not elapsed since the date of Decedent's death.

6. Heirs

The name, physical address where service can be had, relationship to Decedent, minor status, and true interest in Decedent's estate of each of Decedent's heirs, and the only heirs, are as follows:

7. Necessity for Administration

A necessity exists for administration of Decedent's estate in order to settle the affairs of the Decedent and transfer assets that remain to the heirs at law.

8. Children

The Decedent had two (2) children born to him during his lifetime, namely, Andrew Gutttersen born on February 20, 1992 and Paige Michelle Gutttersen born on March 28, 1994.

There were no other children born to or adopted by the Decedent during his lifetime. All children have been listed pursuant to the Texas Estates Code.

9. Marriage History

Decedent was married three (3) times during his lifetime. Decedent was first married to Marla Kilgore on December 18, 1982, in Weld County, Colorado. That marriage ended in divorce on January 4, 1990, in Weld County, Colorado. Decedent was then married to Pamela Lesh in December 1990 in Clark County, Nevada. That marriage ended in divorce on November 2, 2000, in Weld County, Colorado. Decedent was then married to Tammy Barrett on June 27, 2007, in Weld County, Colorado. That marriage also ended in divorce on March 18, 2015, in Hamilton County, Texas. Decedent was not married at the time of his death. All marriages have been listed pursuant to the Texas Estates Code.

10. Existence of Will

Decedent died intestate.

11. Property

Decedent owned real and personal property having an aggregate probable value of at least \$10,000.00.

12. Qualification for Letters of Administration

ANDREW GUTTERSEN is not disqualified by law from being appointed Independent Administrator without bond and from accepting Letters of Independent Administration.

13. No Necessity for Appraisers

The appointment of any appraisers is not necessary for this estate.

14. Agreement on Independent Administration

As provided in Section 401.003, Texas Estates Code, all of the distributees of the estate agree on the advisability of having an Independent Administration and collectively designate ANDREW GUTTERSEN, to serve as Independent Administrator without bond. Waivers of Service and Renunciation of Right to Serve as Independent Administrator in favor of Andrew Guttersen will be obtained from all heirs and filed with the court.

It is further requested that no other action shall be had in the probate court in relation to the settlement of this estate other than the return of an Inventory, Appraisalment, and List of Claims of the Decedent's estate or an Affidavit in Lieu of an Inventory, Appraisalment, and List of Claims.

WHEREFORE PREMISES CONSIDERED, Applicants request that citation issue to all persons having any interest in Decedent's estate as required by law, that this Court determine who are Decedent's heirs and only heirs and their respective shares and interests in Decedent's estate, that there is a need for administration of Decedent's estate, that ANDREW GUTTERSEN, receive Letters of Independent Administration, that no appraisers are appointed, and that this Court enter all other orders it deems proper.




