Debra Allen, Applicant, furnishes the following information to the Court for the probate of the written Will of **Jim Allen**, Decedent, and for issuance of Letters Testamentary:

- 1. Applicant is an individual interested in this estate, domiciled in and residing at 171 CR 3320, Valley Mills, Bosque County, Texas 76689. The last three digits of Applicant's Social Security and Texas driver's license numbers are 699 and 228, respectively.
- 2. Decedent died on November 27, 2024, at Providence Health Center, Waco, McLennan County, Texas 76712, at the age of 59 years. The last three digits of Decedent's Social Security number and driver's license numbers are 271 and 065, respectively.
- This Court has jurisdiction and venue because Decedent resided in this county at the time of death and Decedent owned property interests in this county.
- 4. Decedent owned real and personal property described generally as homestead and other real estate in Bosque County, Texas, bank accounts, vehicles, household goods and personal effects of a probable value of less than \$200,000.

- 5. Decedent left a valid, written Will dated June 25, 2024, the Will, which was never revoked and is filed in this cause.
- 6. The subscribing witnesses to the Will were Patricia Ferguson, who currently resides near China Spring, Bosque County, Texas & Libby Robertson, who currently resides near Clifton, Bosque County, Texas. The Will was self-proved in the manner prescribed by law.
