- 1. Guardian was appointed personal representative of the estate of Ward on October 2, 2024. Since that time, Guardian has administered this guardianship in accordance with the provisions of the Texas Estates Code.
- 2. On October 17, 2024, this court authorized the Guardian's Motion to Sign and Record Lady Bird Deed. A Lady Bird Deed for all real property was recorded with the Bosque County Clerk on October 25, 2024.
- 3. There is no longer a need for a Guardian of this Estate. Guardian has a valid Durable Power of Attorney and can manage the estate.
- 4. This Account for Final Settlement covers the period from October 3, 2024 through January 15, 2025 and is accompanied with proper vouchers in support of each item not previously reported to the Court.
