1. Applicant is an individual interested in this estate, domiciled in and residing at 1505 Blanchard Drive, Round Rock, Williamson County, Texas 78681-6217. The last three digits of Applicant's Social Security and Texas driver's license numbers are 856 and 595, respectively.

2. Decedent died on January 22, 2025, at Beacon Hospice of Austin in Round Rock, Williamson County, Texas, at the age of 93 years. The last three digits of Decedent's Social Security number and Texas driver's license numbers are 212 and 252, respectively.

3. This Court has jurisdiction and venue because Decedent owned property interests in this county.

4. Decedent owned real and personal property described generally as homestead and other real estate in Coryell & Bosque Counties, Texas, savings bonds, bank accounts, household goods and personal effects of a probable value of less than \$2,000,000.

5. Decedent left a valid, written Will dated October 29, 2007, *the Will*, which was never revoked and is filed in this cause.
