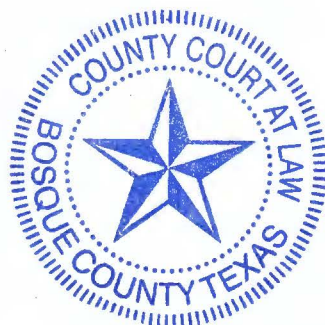

**AMENDED APPLICATION FOR PROBATE OF WILL AND
ISSUANCE OF LETTERS TESTAMENTARY**

TO THE HONORABLE JUDGE OF SAID COURT:

DENA DYANNE BURNS DAY ("Applicant") furnishes the following information to the Court for the probate of the written Will of **HARRY EUGENE DAY** ("Decedent") and for issuance of Letters Testamentary to Applicant:

1. Applicant is an individual interested in this estate and is domiciled in and residing at **419 CR 1191, KOPPERAL, BOSQUE COUNTY, TEXAS 76652**, at which the Applicant can be served.
2. Decedent, **HARRY EUGENE DAY**, who resided at **419 CR 1191, KOPPERAL, BOSQUE COUNTY, TEXAS 76652**, died on **DECEMBER 26, 2024**, at **BALOR SCOTT AND WHITE MEDICAL CENTER, WACO, MCCLENNAN COUNTY, TEXAS**, at the age of **sixty (60)** years. The last three (3) numbers of the Decedent's Texas Driver's License and Social Security Number are 706 and 624, respectively. The last three (3) numbers of the Applicant's Texas Driver's License and Social Security Number are 792 and 307, respectively.
3. This Court has jurisdiction and venue because Decedent was domiciled in and had a fixed place of residence in this county at the time of Decedent's death.

4. Decedent owned personal property described generally as cash, securities, household goods, personal effects, and real estate of a probable value in excess of \$50,000.00.

5. Decedent, **HARRY EUGENE DAY**, left a valid written Will dated **AUGUST 23, 2014**, that was never revoked and is filed herewith.

6. The subscribing witnesses to the Will are **JAMES L. WRAY**, whose address is currently unknown, and **CAROL J WRAY**, whose address is currently unknown. The Will complies with the requisites of Texas law. The Will was made self-proved in the manner prescribed by law.

7. No children were born to or adopted by Decedent after the date of the Will.

8. No marriage of Decedent was ever dissolved after the Will was made, whether by divorce, annulment, or a declaration that the marriage was void.

9. A necessity exists for the administration of the estate.

10. Decedent's Will names **DENA DYANNE BURNS DAY** to serve without bond or other security as Independent Executor. Applicant would not be disqualified by law from serving as such or from accepting Letters Testamentary, and Applicant would be entitled to such Letters.


11. Decedent's Will did not name either the State of Texas, a governmental agency of the State of Texas, or a charitable organization as a devisee.

Applicant prays that citation issue as required by law to all persons interested in this Estate; that no further action be had in this Court other than the filing of an affidavit of inventory appraisement and list of claims as required by Texas Estate Code Section 309 and those required
